# 1892 Credit Reports Campbell County, Tennessee

Editor's note: While processing some Knox County Chancery Court case files, Eric Head came upon an interesting case (File #5354) in which Robert G. Dun of The Mercantile Agency of New York City filed a complaint against James J. Mars, J. B. Montgomery, and Jeremiah Smith of Campbell County for allegedly having failed to turn over collected debts. (The Mercantile Agency of New York City was formed in 1841 to create a network of correspondents who would provide reliable, objective credit information, and collect debts. In 1933, it merged with competitor R.G. Dun & Company to form today's Dun & Bradstreet.) One of the exhibits in the case file was a list of credit reports on various individuals and companies located in Campbell County. The reports are a treasure trove of information, such as age, occupation, reputation, estimated worth, length of time in Campbell County, former residence, etc. A transcription of the reports, all dated February 26, 1892, follows. They have been rearranged in alphabetical order with only minor editing for clarity.

#### Africa, J.C. / Contractor / Jellico

Formerly of Cooley & Africa, which firm he succeeded something over a year ago; he is a married man, about 40 years of age, of good character, steady habits and fair capacity; in addition to his contracting, he has a small coal mine; he owns some real estate consisting of a house and 3 or 4 acres of land, and several other lots in this town. Is estimated worth clear from 3 to \$5,000. Looked upon as an honest straightforward man; prompt in his payments and not likely to enter into any contract he would be unable to fulfill.

#### Alvey & Mars / Drugs / Jellico

No change from late report.

#### Atkins, L.L. / G.S. [General Store?] / High House

Married man about 30 years of age; in this business here 4 or 5 years; bears an average reputation and is of ordinary capacity. He owns farm land worth about \$2,000; carries a stock estimated at 6 to \$800. So far as known is satisfactory in his payments, and believed worth in the neighborhood of \$1,000 or \$1,200 clear; regarded safe for reasonable business requirements.

#### Baird, M.E. / G.S. / Elk Valley

A young married man about 24 years of age, of good character and habits and very fair capacity. Commenced this business in the Spring of last year, his father Z.D. Baird is the silent partner, he owns real estate worth about \$1500 and is also a member of the firm of Baird Bros. general mdse. this place, he constitutes the responsibility in this case. The firm carry a stock of \$1500 and said to be in pretty good standing and no complaints are heard as to manner of meeting obligations. An estimate of \$2000 is believed about right and they may be looked upon as good for their reasonable wants.

#### Baker & Harless / G.S. / Boy

Young men without much experience who have been engaged in this business about 9 months, they have only a light investment of probably 3 to \$400 represented by stock. Own no real estate and about making a living out of their business and nothing over, while there have been no complaints heard as to the manner of meeting obligations they present no financial responsibility whatever and if credit is accorded them must be on the score of honesty.

#### Bibee, J.M. / Hotel / Jacksboro

This man runs the "Central House;" is also connected with the Elk Valley Coal & Iron Co.; married, upwards of middle age, has resided here 12 or 14 years, for some time engaged in merchandising. Owns good farm property and town property besides, and is estimated worth from 20 to \$25,000. Very prompt, reliable and safe.

#### Big Creek Gap Imp. Co. / Big Creek Gap

This concern is incorporated with an authorized capital of \$25,000. The incorporators are J.E. Johnson, J.J. Mars, C.W. Alexander, Robt. Mullins and J.B. Hoeing. The "Co." owns 300 acres of land, consisting of town sites and marble quarries, etc. Those connected are all good men; just how much of their capital is paid in cannot say, but the "Co." is believed entitled to any reasonable credit.

#### Bridgewaters, Mrs. N. / Mill'y. [Millinery] / Jellico

Honest industrious woman who has about \$100 invested in her business; her husband is living, consequently she could not make a binding contract, although she is said to pay her little bills and might be trusted for small amounts on short time on the score of honesty.

#### Buckner Bros. / Saloon / Jellico

B.M. and G.L. Buckner have been engaged in this business some 6 years; came from Summerset, Ky.; both married, aged respectively 28 and 32; they possess good general reputation and capacity for their line of business. They own business premises worth probably \$5,000; probably have an investment in their business of \$800 to \$1,000; they are well spoken of, believed to be making money, and looked upon as good and safe for any favors they will ask.

#### Cannon & Hunter / Gro. / Jacksboro

Wm. B. Cannon and Jno. H. Hunter are still the members of this firm, both married men, wards of middle age, of good character, steady habits, ordinary capacity; in this business 1 <sup>1</sup>/<sub>2</sub> years. Carry an average stock of say \$500, but own real estate consisting of town and farm property worth from 5 to \$6000. Hunter was a farmer and still devotes his time mainly to farming, Cannon is a carpenter by trade. They are considered honest, but not very much business men; are worth say 3 or \$4,000 net; so far as known pay their debts satisfactorily, and may be considered a fair risk in a moderate way.

## Carr, W.H. / G.S. / Caryville

Good, reliable, young married man, aged 30 or 35 years of age; in this business here some 4 years, with fair success. Carries a stock estimated at 3 to \$4,000; owes but little, has an interest in his father's estate in Claiborne Co., and is estimated worth at least \$2,000 above debts and exemptions; pays promptly, has fair prospects and is regarded a fair risk for moderate wants.

#### Cates, J.W. / G.S. & Hotel / Newcomb

Failed about 3 or 4 years ago and old accounts are still unsettled. Acts as agent it is said D.H. Rosier; is a man 45 years of age, divorced, and has several children to support. Owns a little real estate but same would be exempt. Rosier is not thought to have much financial responsibility, and Cates is not financially responsible. Carries a stock estimated at 12 to \$1500. While so far as known now his debts are promptly paid, the responsibility in this case is extremely indefinite, and caution should be used in extending credit.

#### Claiborne, J.H. & Son / G.S. / Well Springs


This is a good firm, the members thereof being J.H. & Wm. Claiborne, both are members of the firm of Claibornes, Woods & Brown, Clo. & Mens Furng. Of Knoxville. They carry a good stock here; the senior Claiborne owns valuable real estate worth say 8 or \$10,000, and with his outside interest is estimated worth 12 to \$15,000 net. The son is supposed to have mainly a working interest in the business at this point. They are doing well, prompt in their payments; have good prospects, and may be considered quite safe for their reasonable business requirements.

# Connelly, B.A. / Tanner / Jellico

This man owns a valuable plant here, which with his real estate in Campbell Co. is variously estimated worth \$75,000; he is said to have a considerable amount of other property. Employs a number of hands here and does quite a large business, but manufactures mainly for one eastern house; came originally from Rome, Ga., where was a member of the firm of Connelly & Bye. He was absent from town when called upon and no statement was obtainable, in fact he has always declined giving a statement of his affairs. Has the reputation of being an honorable, energetic man, who meets his engagements promptly. The belief is expressed that he is amply responsible for any contract he will enter into, but no definite estimate of worth is obtainable.

# Cook, H.G. / Jeweler / Jellico

Young single man, who came here from Chicago, it is said, about Nov '90; is a son of H.J. Cook, who is of the firm of M. Greer, jr. & Co. of Knoxville, was formerly in the same line in Chicago. The young man is worth 2 or \$3,000; he is considered honest, of good habits, attentive to his business. His father has some means, and it is said will assist him if necessary, but the young man is thought to possess much responsibility.

# Cordell, J.K. / G.S. / Newcomb

About 50 years of age and married, of good character and habits and fair business capacity; was a farmer until about a year ago, when he engaged in this business, has a stock estimated at about 5 or \$600, some few accounts outstanding and is reputed to own a farm worth 12 to \$1500, so far as known appears to be in fair credit and to have met his obligations satisfactorily and it is not thought that he would abuse a limited line of credit.

# Daisy Coal Co. / Coal Mining / Jellico

This is not an incorporated "Co." The partners interested are R.H. Randles, C. Wilmot and E. Blizzard. The latter states that they have a capital invested in the business of \$2,500, which is represented by their mine, outfit etc. They have but a small mine located in this vicinity, which has but a limited outfit. Randles is the main man; is in general store business here, married, 25 or 30 years of age. Carries a stock of mdse. of about \$2,000, a good man, has been here some time and always paid. Neither Wilmot or Blizzard are known to have any property or outside resources, and such credit as is accorded this Company must be based upon the responsibility of Randles. See R.H. Randles.

# Douglass Bros. & Baird / G.S. / Newcomb

These are all married men, aged respectively 33, 35 and 29. Succeeded Perkins & Baird about 2 months ago; men of good character and habits, fair capacity. Have a stock estimated at \$800 to \$1,200. They are not known to own any real estate. So far as known they pay satisfactorily however and are looked upon as reliable, honest men, of limited financial responsibility.

# Douglass, W.O. / "Sentinel" / Jacksboro

Young single man, about 30 or 35 years of age, in this business a couple of years; was formerly county surveyor; of good habits, industrious and fair capacity. Has about \$1,000 invested in the newspaper plant; owns a house and lot at Newcomb, another one at Jacksboro. He is believed worth \$1,000 to \$2,000 clear. Is regarded honest, so far as known prompt in his payments and looked upon as a fair average risk.

# Elk Valley Coal & Iron Co. (Inc.) / Elk Valley

Sound, responsible and well conducted corporation. Have made improvements of late at an estimated cost of \$50,000. They own 8 or 10,000 acres of timber and coal land. The officers are the same as heretofore reported. The authorized capital is \$400,000, full paid, which is represented by their land, plant etc. The men connected with the enterprise are reliable and have large outside resources. Credit and standing of the Company may be classed high.

# Ellison & Co. / G.S. / Jellico

No change from late report.

# Gaylor, J. & Bro. / Blksmth. / Newcomb

J. Gaylor is the only man known to have anything to do with this concern; a brother used to be associated with him, but is not about here now. J. Gaylor only has a small home, and a small amount invested in tool and material. Has quite a large family; is an honest, industrious mechanic, about manages to make a living, but nothing over; is worth nothing collectible, and has no basis for outside credit except it be honesty.

# Gaylor, W.M. / Saw Mill / Whitman

Married, 35 to 40 years of age; engaged in this business several years, formerly farming, of good character and habits, industrious, and of fair capacity. Owns a small farm worth about \$1,000 or \$1,500; has about \$800 to \$1,000 invested in his mill and personal property appertaining. Is estimated worth \$1,000 net. Said to be prompt pay, and thought good for moderate favors.

# Gibson, Lawson & Co. / G.S. / Elk Valley

F.M. Gibson, Andrew Lawson and C.B. Lay are the names of the parties interested, or known to be, but it is thought there are others connected with it, and that it is an Alliance store. Report of July last fully sets forth condition, standing etc. They carry a stock estimated at 12 to \$1500. The parties above mentioned constitute a responsibility of from 4 to \$5,000 at least, over debts and exemptions. Appear to be doing a fair business, and no complaints whatever heard as to manner of meeting obligations.

# Graham & Sharp / G.S. / Jacksboro

These men are brothers-in-law, both married, of good character, temperate habits, very fair capacity, ages 23 and 27. J.J. Graham has a little real estate consisting of a house and lot worth \$1500. J.F. Sharp has a farm worth \$2,500; they carry a stock of 4 to \$5,000; doing a good business; prompt in their payments; have good prospects, and are looked upon as a good safe firm. Net worth placed at from 4 to \$5,000, and entitled to responsible credit favors.

# Gray, J.F. / Saloon / Jellico

Single man about 30 to 35 years of age, who has been engaged in business for himself since the latter part of 1890, previously clerked for others, of good character and habits, industrious and of fair capacity. Carry a small stock, say 5 to \$600, has perhaps a little property besides and is not thought unsafely indebted. Estimated worth perhaps \$500 net, and a fair risk consistent with his means.

# Gray, Jos. / G.S. / Big Creek Gap

Married, of good character, habits and capacity, Trustee of the Co. Carries a stock of 3 to \$5000 and owns home and land in Jellico worth \$1500; also owns 1/2 interest in the the firm of Gray & Roach at this point and is not believed owing very much. And is estimated worth about \$5000, has good prospects and is looked upon as a fair risk for his requirements.

# Gross, G.W. & M. Kelly / Saw Mill / Big Creek Gap

These men have been in business since Jan '91 as above, at which time they succeeded A. Gross & Son. Individual names, G.W. Gross and M. Kelly; both married, of good character, steady habits and fair capacity. Gross is the monied man, farming principally; owns a good farm. They have an investment in their business of perhaps 5 or \$600 and as a firm are estimated worth \$1500 to \$2,000 net. Said to pay their debts satisfactorily and may be considered a fair average risk.

# Hamon, Jacob / G.S. / Pioneer

This man lives in Scott Co., Tenn. Is said to be a substantial farmer there; he has but a light investment at this point, not to exceed a few hundred dollars. From Scott Co. it is learned that he owns property worth about \$3,000 in real estate and personally \$1,000; that he has always borne a good reputation for honesty; prompt in meeting his obligations and looked upon as good and safe for any reasonable credit.

# Hampton, Geo. / Blksmth. / Fincastle

Married man about 60 years of age; in this business several years in a small way, steady, industrious mechanic; has a light investment in his business of say 3 or \$400, but owns a farm of 120 acres and a lot, and is worth about \$1500 to \$2,000 above his debts and exemptions. Said to pay promptly, and good and safe for any favor he is likely to ask.

#### Hatmaker, J.M. & Co. / G.S. / Jellico

Formerly reported as J.I. Hatmaker & Co., correct style is J.M. Hatmaker & Co. Ruby York being the Co. They are men of fair general reputation and of ordinary capacity, have a very light investment, not to exceed 2 or \$300 and are not making more than a living, but so far as known have paid their debts promptly, they have really no legal responsibility and present no basis for unsecured credit.

#### Hatmaker, Lindsay / G.S. / Hatmaker

Married man 45 to 50 years of age; principally a farmer, in merchandise business 2 or 3 years in a very small way; bears a good reputation for honesty and is of ordinary capacity. Carries a stock of probably \$500, owns 150 acres of land worth \$800 to \$1,000, some personal property on farm and is considered worth 5 or \$600 over debts and exemptions. No complaints heard whatever as to manner of meeting obligations and regarded safe for moderate wants, in accordance with his means.

#### Heath, W.L. / Hotel / Jellico

W.L. Heath is located on the Ky. Side, is a married man, who came here some 3 or 4 years ago from some point in the North. He keeps a good house, leases the hotel, but is probably worth \$1500 to \$2,000 clear; has the reputation of paying his debts promptly, and may be considered good for such reasonable credit as he is likely to ask in connection with his business.

#### Hefferman, J.L. / Physician / Newcomb

A reputable physician, who has been engaged in the practice of his profession here some 5 or 6 years with pretty good success; has had the patronage of the coal Cos. In this vicinity and has made some money; young married man, about 30 years of age, of steady habits and good capacity. Owns little if any real estate, but is said to have 3 or \$4,000 in Bank, and to pay all obligations promptly.

#### Hunter, Squire / Saw Mill / Buckeye

Married, 60 to 65 years of age, of good character and habits, fair capacity. Owns his saw mill, a house and lot and about 600 acres of land in this and Anderson Cos. Is estimated worth \$3,500 clear; pays promptly and is regarded safe for any favor he is likely to ask.

#### Hutson, I.G. / G.S. / Hatmaker

Married, 35 years old; over a year in this business, a native of this county, previously farming. Man of good character and habits, owns farm worth about \$1000. Usually pays promptly and has fair home credit. Worth nothing over exemptions. Regarded honest and fair risk for moderate favors.

#### Hutson, J.G. / G.S. / Hatmaker

Married, 35 to 40 years of age, native of this county, formerly engaged farming; in this business little over a year; has but a small stock, no real estate except what would be covered by exemptions. Worth nothing over and above debts and exemptions. Does a fair small trade, about makes a living, nothing more. Is hardly strong enough to admit recommending for credit favors.

# Interstate Manfg. Co. / Lumber & Furn. / Newcomb

This is a good Co. incorporated under Tenn. State laws with an authorized capital of \$50,000 of which \$38,000 is paid in, represented by plant, stock, manufactured and unmanufactured and real estate. A.J. Smith is Pres., Y.P. Rhodeheaver, Secy & Treas and T.H. Rhodeheaver, Gen'l. Mngr. Parties interested in this Co. have outside resources and are looked upon as reliable men. The Company's obligations are said to be promptly met, and the concern entitled to good credit.

# Kelley, Jas. D. / Undtkr. / Jellico

Here some 3 or 4 years, married, 50 years of age, character and habits fair; formerly of Smith & Kelley; came from Ky. Investment small, say 2 or \$300; owns no real estate and has nothing whereon to base credit.

# Kinkaid & Mullen / G.S. / Fincastle

A.C. Kinkaid and C. Mullen, aged respectively 40 and 21. Kinkaid is a widower, Mullen married. Men of good general reputation and very fair capacity. Engaged in this business together for the past 2 years or so. Kinkaid was previously alone, and for a time clerked for a Knoxville house. Mullen was a farmer. Carry a stock estimated to be \$3,500. Kinkaid owns real estate worth \$3,000. Mullen also has considerable real estate and personal property, and they are estimated worth as a firm about \$12,000. Doing a good business, satisfactory in their payments so far as can be learned, and regarded a fair risk for such credit as they are likely to ask.

# Lay, E. / Blacksmith / Powells River

An industrious man, a fair mechanic, married, about 40 years of age, no real estate except what would be exempt, has but a little investment, about makes a living. While so far as known he pays as he agrees, he has no financial responsibility or basis for unsecured credit.

# Lay, H. & Son / G.S. / Elk Valley

Both married men, senior about 62 years of age, junior about 40. Full names, H. and Jas. Lay; in this business here a little over a year; previously at Huntsville for 4 or 5 years; men of good general reputation. Own their business property. Carry their stock of 12 or \$1500; have some outstanding accounts and personal property besides; not believed unsafely indebted. Estimated worth net as a firm about \$1,000 net. No complaints heard as to payments, and a fair risk for reasonable credit.

# Lay, Will / G.S. / Powells River

Was associated with his father in this business for some little time, prior to which was on a farm. Young single man, about 23 years of age, of ordinary capacity only. Has a very limited investment, no real estate and no financial responsibility. Claims in the hands of attorney which cannot be made. Certainly is not in shape to admit of advising further credit.

# Leinart, C.H. / G.S. / Fincastle

Engaged in this business a number of years, with a good record, married, about 57 years of age, of good character, temperate habits and good capacity. Owns 12 to 1500 acres land; carries a stock estimated at \$5,000, has livestock and personal property on farms and is estimated worth at least 25 or \$30,000. Prompt in his payments and amply responsible for what he will contract.

## Little, J.B. / Grist Mill / Well Springs

Quite an old man, in the neighborhood of 70 years of age, a Methodist preacher, has been milling for a good many years, at all times favorably spoken of. His son is a member of the firm of Powers, Little & Co. of Knoxville; the father owns about 300 acres, mill property and some personal property besides and is estimated worth at least \$2,000 clear; has the reputation of paying always as he agrees and may be considered a good risk for reasonable credit.

# Littlejohn, Jno. D. / Publisher / Jellico

This man is publisher of the "Advance," a newspaper here; also does job printing; came from Carter Co., Ky., married, 25 years of age, honest, industrious, steady young man, of fair capacity. Said to have about \$1500 invested in plant, nothing else. Net worth placed at \$500 to \$1,000. Pays as he agrees, and is regarded safe for reasonable credit favors.

#### Logan, W.M. / Saloon / Jellico

Succeeded G.W. Wilson last fall. Claims to have a stock of \$500, to have some outstanding accounts and cash 2 or \$300, and to owe about \$200. As will be seen he has little if any responsibility. Could not be forced to pay if he did not choose to; 24 years of age, married, formerly a bartender, came from Barboursville, Ky. Reputation fair for one in his business, doing just fairly, credit however should be just limited.

#### McCarty, Jno. W. / Saloon / Jellico

Married man about 38 or 40 years of age, who has been engaged in business here 7 or 8 years and has been successful to a moderate extent; reputation however is not the best in some respects; yet he is reported as prompt in the settlement of his indebtedness. He owns a house and lot in town worth \$5,000, other real estate in this vicinity; has an investment of perhaps \$1500 in his business, and his net worth is placed at from 7 to \$10,000. It is not believed he would enter into any contract for supplies he would not carry out. Credit may be classed fair.

#### McClintock, F.A. / Phys'n. / Newcomb

Has been engaged in the practice of his profession here for some years; came here from Ohio, and at first clerked here, single man, about 30 years of age. General reputation and capacity fair. Has no property and nothing whereon to base credit.

# McNew & Maupin / Saw & Grist Mill / Well Springs

F.P. McNew and Ayres Maupin compose the firm; are brothers-in-law, the latter is quite an old man, 80 years of age and single. McNew is a married man about 76 years of age. Maupin is the monied man of the firm, owns good real estate and is worth 10 to \$12000 at least, which in all probability McNew will eventually inherit. They have a fair stock; have a pretty good trade; prompt in payments and Maupin makes the firm good for any reasonable credit.

#### Miller Bros. / G.S. / Stockville

Jno. B. & Jas. P. Miller compose the firm, both married men, between 25 & 30 years of age, of good character and habits and fair capacity, bears the reputation of being honest and straightforward in their dealings, own farm lands in Campbell Co. and property at Knoxville, Tenn. Generally carry stock of \$8000 or thereabouts. Are believed worth safely \$10,000 above debts and exemptions. Reputed prompt and satisfactory in their obligations and looked upon as a good safe firm to deal with.

## Miller, J.P. & Bro. / G.S. / Caryville

J.P. and J.B. Miller compose the firm, both married men, ages about 38 and 36, have been engaged in this business here as above 3 or 4 years, succeeded J.P. Miller, who was alone for 7 years, and J.B. "M" was of Smith & Miller at Wells Spring; men of good general reputation, excellent capacity, industrious and accumulative. Carry a stock estimated at 5 to \$6,000; own good real estate in this county and some in Knoxville. Estimated worth clear 15 to \$20,000. Prompt in payments, making money and regarded quite safe for any contract they will make.

#### Montgomery, A.M. / G.S. / Girlton

He is a married man, upwards of 50 years of age, who has been engaged in merchandise business at this point for several years, with a good record. He owns real estate consisting of 150 acres of land worth \$1,000. Carries a stock estimated at \$1,000 or \$1,200; is not known to be owing unsafely; has some livestock, personal property, outstanding accounts etc. and is estimated worth \$800 to \$1,000 net. Honest and prompt, a fair risk for reasonable credit.

#### Newman, A.T. / Drugs / Jellico

Married man, 40 years of age, in this business  $1 \frac{1}{2}$  years, came from Newcomb, this Co. where was engaged in practicing medicine for 4 or 5 years, also carried on a drug store; is of good character, steady habits, and good capacity; has always been looked upon as an honest, reliable man; has been fairly successful. Owns real estate worth 5 or \$6,000, has money in bank and out on interest. Estimated worth clear 6 to \$8,000. Prompt pay and a reliable, safe man to deal with.

#### O'Riley, R. / Hotel / Jellico

Formerly reported as R.O. Riley, above is correct. This man has no property or financial responsibility whatever. His wife owned the hotel property worth \$3,600; she is a woman of good capacity, regarded honest and reliable, but according to the Tenn. Laws cannot make a binding contract, being a married woman. So far as known pay their debts satisfactorily, but basis for credit must rest upon honesty.

#### O'Riley, Wm. / Gro. / Jellico

Young single man about 20 to 21 years of age, engaged in this business 6 months or thereabouts. Has a stock of probably 4 or \$500; said to have some cash in bank, but owns no real estate or outside means. His mother has property and is reported to be backing him; he is hardly yet of age and consequently his responsibility is doubtful.

#### Perkins, J.L. & Son / G.S. / Newcomb

Succeeded Baird & Perkins about March '91; men of good general reputation and fair business capacity. The senior owns a house and lot and a farm worth about \$2,000 all told. Firm have a small stock of goods, say \$800 to \$1,000. The young man has nothing aside from such an interest as his father may give him. They are doing fairly, have the reputation of paying satisfactorily. Worth at least \$1,000 to \$1,200 net, and looked upon as a fair risk for moderate wants.

# Pine Mountain Coal Co. / Newcomb
