Incorrect Example

Donelson had to transport supplies for the new settlements as well as a large number of women, children and enslaved people by way of the Holston, Tennessee, Ohio and Cumberland Rivers. What is wrong with the example?

Corrected Example

Incorrect Example

This example contains a direct quote that is not enclosed in quotation marks.
